**Course Description:** . Downhill start down Stout St. and Main Street in Pittston. Over Water St bridge to left onto Susquehanna Ave. Right on Delaware Ave, left onto 2<sup>nd</sup> St. and a right onto Boston Ave finishing with a lap around the track at Wyoming Area stadium
